NO TRUMP OPENINGS (part 2)

In last month' newsletter I wrote about opening 1NT with 15 - 17 or 12 - 14 high card points. As I promised there are also other options.

Apart from the fact that you will open 1NT more often with 12-14 HCP (and hence may get into trouble more often) there are other considerations, particularly when partner is weak (< 8 HCP). Firstly, if you open 1 Minor with 12 HCP and partner responds with 5 HCP, you may find yourself in a precarious 1NT with a combined 17 HCP (or 3NT with a combined 24 HCP if you jump to game with 19 HCP). The opposition, with 23 HCP, don't have enough points for their own Game and may choose to defend rather than compete for a part-score.

Using the Weak NT, 1 Minor followed by a rebid of 1NT shows 15-17 HCP, so if partner has responded to your 1 Minor with just 5 HCP you will at least have 20 HCP combined. The second point is almost the converse of the first. Opening a 15-17 1NT when your partner has < 5HCP may leave you struggling to make your contract unless your opponents compete. The Weak NT opening of 1 Minor with the same hand is more likely to induce the opponents to compete when they might have achieved a better score by defending (depending on vulnerability and the nature of the fit if they have one).

3. THE "ULTRA" WEAK NT: Arguably, hands with 10-12 HCP will occur with the greatest frequency. George Cuppaidge (columnist in the QBA Bulletin, once Senior Counsel resident in Brisbane but now resident in Thailand) used to advocate strongly in his columns that with 10 HCP you should enter the bidding, particularly in first seat. Why not? There are not many top name players who espouse a 10-12 HCP NT opening, and few who write about it. Given the propensity of some of our Club players to open single 5-card suited 10 HCP point hands at the 1 level, I'm a little surprised they haven't tried the 10-12 1NT opening. My only comment is that if you open on 10 HCP, your partner needs 15+ HCP to bid Game. In which case, why not let them open a Strong NT so you can control the auction. Next month there will be more on point ranges.

The Barrier Reef Congress

The inaugural Barrier Reef Congress was held in Townsville in 1996. Something of the history of this Congress is given in *Mind Games: a biographical history of bridge in Queensland* edited by Colin Masters, Queensland Bridge Association, 1999.

The impetus for this congress came from the Mackay Contract Bridge Club which raised with the Australian Bridge Federation the distance problems facing players in north Queensland wishing to accumulate gold points. In 1993 there was a meeting in Townsville between Eric Parsons (Mackay), Jan Smith (Cleveland Bay) and Laurie Kelso (Townsville) to coordinate a joint northern lobbying effort to achieve such a congress.

2017 LAW CHANGE By Bill Bishop

There has been a number of changes in the 2017 Laws of Duplicate Bridge, one of these is Law 23, Comparable Call.

The definition of a comparable call is: A call that replaces a withdrawn call is a comparable call if it:

- 1. 1. has the same or similar meaning as that attributable to the withdrawn call, or
- 2. 2. defines a **subset** of the possible meanings attributable to the withdrawn call, or
- B. 3. has the same purpose (e.g. an asking bid or a relay) as that attributable to the withdrawn call.

Before allowing a comparable bid the Director must ensure that the replaced call meets **one** of the above criteria listed. Here are some examples.

WEST is the Dealer in all cases. The call out of turn is not accepted.

Answers:

- !: No, this is an insufficient bid and !st option is to correct to the lowest level in the same denomination. Next option is a comparable bid,a X is not considered comparable.
- 2: No
- 3: a, if 2S shows a fit in Hearts and a good hand

YES Same or similar

b, if 2S initially shows a fit in Hearts and a good hand and sometimes shows just a good hand with no easy bid YES Same or similar
