DIRECTOR'S CORNER

When the Director is Called

Whenever there is a perceived infraction at the table, the director must be called. Any player may call the director, but the Dummy cannot call the director until there is an agreement at the table that an infraction has occurred. Remember, there is <u>nothing personal</u> in this. The director's role is simply to determine whether a breach has in fact occurred, and to restore equity where possible. It is not to 'punish' the offending side or the particular offender.

It is difficult for the director to make a ruling if there is argument or if a number of people want to speak at once. Generally, the person who called the director should become the spokesperson for the table initially and they should only speak at the director's request. The director may ask some direct questions to establish the breach that may have occurred and then see whether there is agreement. If there is a dispute, other table members will be given an opportunity to speak. If there is an infraction, the director will make a ruling based on the law or regulation concerned. If there is a disagreement about the ruling, the persons concerned may politely ask the director to check.

The ruling may be appealed up to 30 minutes after the event if it still thought to be incorrect. Some rulings (e.g. bidding after a partner hesitates and then passes in a competitive auction) may not be able to be made until the end of play.

The process should proceed in an atmosphere of friendliness as much as possible. Remember, at some point you may be the 'offender'.

Another Slam

You can usually tell when Friar Andrew has had a good result because his normal smiling face beams even larger.

The other day when I arrived at his table he was grinning from ear to ear. "We got a complete top – nobody else was even in a small slam let alone the grand".

After congratulating him, he went on "of course, we had to have a couple of bidding misunderstandings to get there"!!

THE ABF NEWSLETTER

I have always tried to improve my bridge. Ideally, I would like to do this through discussion with my regular partners but there rarely is the opportunity for this. I fall back on reading but since I haven't finished a book in years, I've stopped buying them and restrict myself to the Australian Bridge magazine, the ABF Newsletter and the QBA Newsletter (when a paper copy reaches the Club).

The ABF Magazine has recently had another change of editor. Under Barbara Travis's stewardship it introduced more instructional articles, many written by Barbara herself. It continues in this vein under Brad Coles. If you follow those players who represent Australia then you will recognise the names: Barbara Travis, Brad Coles, Paul Lavings, Ron Klinger, David Lusk, Warren Lazer and Will Jenner-O'Shea, all write for the ABF Magazine. Joan Butts has a regular feature and recently articles written by the US teacher Eddie Kantar have been reproduced. If you want to extend your views on bidding there is always the more radical views presented by George Cuppaidge to consider as well as Paul Lavings more conventional 'Bridge into the 21st Century'.

This month I particularly want to draw your attention to Eddie Kantar's '24 Bidding tips' (June 2019 issue) and '25 Defensive tips' (August 2019 issue). These articles are almost beginner level but they provide answers to the type of problems players face every day - situations that cannot be taught in classes (because classes would go on forever) and can only be learnt through play (which is what we all want to do).

Some of the bidding tips are obvious, others I hadn't considered (like giving preference to partners opening suit even when it is at a higher level). I particularly liked Tip 4: 'When the bid on your right is strong, a jump by you is weak. When the bid on your right is weak, a jump by you is strong.' Isn't that easy to remember? Often, Eddie gives hands that illustrate his point. There are too many tips to

discuss them all here but Tip 23 is worthy of note: 'Once a player limits his hand, the partner is the captain and is supposed to make the final decision. Captaincy can be reversed however, if the captain turns the tables and makes an invitational bid'. Eddie gives 3 examples to illustrate this. Eddie Kantar's 24th tip on bidding is the easiest to accept: 'Only play conventions you are both comfortable with.'

There are 25 defensive tips on leads, some of which appear to go against the grain. For instance, in Tip 2, Eddie says when leading a supported suit or just leading partner's suit to lead the King from an AKx holding. 'Leading the Ace... denies the King.

Try this one: Against 3NT, your partner leads a small Spade (promising an honour) and you hold: K Q 10 9 x. There is a singleton Spade in dummy. (Declarer is on your left.) Which card do you play? If partner has lead away from the Jack, the 9 will do. If he has led away from the Ace the Queen must be played. All the bidding tells you is that Declarer has confidently bid 3NT showing a stopper in a suit she didn't bid. I played the Queen. The result: Declarer made 3NT with 1 Spade stopper because partner didn't see my subsequent signal to continue Spades. It didn't help that 4 Hearts (by the opponents) would have 11 tricks.

While Eddie Kantar's tips need careful reading, I think they are well worth the effort. What will he have to offer us in the next issue of the ABF Magazine?
